1. Introduction to PSP 2.0


The PSP 2.0 process involves co-designing the PSP with key stakeholders through a series of structured workshops (pictured below). These workshops include:

- Pitching sessions (completed)
- Vision & Purpose Workshop (Monday 27 June 2022)
- Co-design (late 2022)

Each stage of the PSP process works to gradually develop a draft PSP that is taken through agency validation, and on to public exhibition. Throughout the process, a series of summary documents will be produced and distributed to all stakeholders. The summary documents provide a record of the work that was completed and provides the foundations for the next stage of the PSP.

While it may not be possible to resolve every issue through the workshop process, it provides stakeholders with a shared understanding of the project objectives and a clear line of sight regarding how decisions have been made.

2. Vision and Purpose Workshop

The Vision and Purpose workshop is the second workshop in the PSP 2.0 process. It seeks to establish an overarching vision for the precinct, its purpose and place, and any important opportunities stakeholders would like to particularly focus on. All stakeholders will be invited to the Vision and Purpose workshop, including landowners and government agency representatives. Workshop activities will be designed for collaborative discussion and will look to achieve the following objectives:

- Validate key issues to be resolved through the planning process based on the four themes identified through the Pitching Session Summary Document.
- Establish an agreed vision and purpose for the Melton East PSP.
- Gain consensus or establish points of disagreement among stakeholders to avoid reprosecution of issues later in the process.





3. How to Prepare for Vision and Purpose

Landowners and Developers

Pre-reading of the Pitching Session Summary Document is recommended to get the most out of this session. However, a quick update and run through of the key points from the document will be provided at the start of the session.
